President's Report

To All Members: You must make your December 20th luncheon reservations by December 11th as we will not accept any reservations after that date and there will be no walk-ins the day of the luncheon. The final count for the luncheon will be given to the Penn Harris on December 11th. If you have any questions on your reservation, contact Tom Hoffman at 717-652-3435.

Remember: You have a choice each month of the alternate meat choice of chicken, vegetarian, or gluten free dinner, but you must remember what you ordered as we get tickets for those meals ordered. For this December luncheon only, a choice of either the ham dinner or the turkey dinner is the main entrée and tickets are ordered for the number ordered.

ATTENTION: As Tom gets his mail late in the day, you need to send your reservation in shortly after you receive the newsletter. Also, the newsletter is on the WEB site. Because of the reservation count, if you contact Tom and say you are not sure about coming but will pay at the door, please remember to contact Tom back to let him know whether you will or will not be there. **REMEMBER, IF YOU FEEL THAT THE POST OFFICE WILL NOT GET YOUR CHECK TO TOM BY THE DATE REQUIRED, GIVE HIM A CALL TO MAKE YOUR RESERVATION AND THEN SEND HIM YOUR CHECK OR TELL HIM YOU WILL PAY AT THE DOOR.**
